**PLEASE READ THE RULES CAREFULLY**

THE GCCF RULES THAT NO EXHIBIT MAY BE ENTERED FOR COMPETITION TWICE IN 13 DAYS.  
THIS RULE INCLUDES ALL OTHER CATS AND KITTENS FROM THE SAME CATTERY/HOME

RULE 3 - In order to exhibit in any Show held under GCCF licence the exhibitor must complete the official entry form for the show and abide by and subscribe to the following declaration:-

- (a) I/We am/are the registered owner(s) of the cats and/or kittens named on this form and I/We agree to be bound by and submit to the constitution and Rules of the Governing Council of the Cat Fancy presently in force and to any additional Rules formulated specifically for this Show, provided only that the latter do not conflict with the former. AND/OR I/We shall have applied for registration/transfer at least 21 days before the Show.
- (b) No cat owned by me/us or living at the same address will be exhibited at or entered for any Show or Public Exhibition held less than 13 days prior to OR following the date of this Show / Exhibition. NB the owner of a cat is the person so named in the GCCF register (Section 4 Rule 2)
- (c) (i) In the event of ear mite infestation being diagnosed in my/our cattery/household by a Veterinary Surgeon, no cat owned by me/us or living at the same address will attend any Show / Exhibition until such time as all cats owned by me/us and/or living at the same address have been examined by a Veterinary Surgeon and pronounced free from ear mite infestation.  
(ii) In the event of ringworm infection being diagnosed in my/our cattery/household by a Veterinary Surgeon, I/ We will inform the GCCF Office and neither I/We nor any cat owned by me/us or living at the same address will attend any Show / Exhibition until at a Clearance Certificate, as required by the GCCF has been obtained.  
(iii) In the event of any other infectious disease, with the exception of Feline Leukaemia Virus or Feline Immunodeficiency Virus, being diagnosed by a Veterinary Surgeon in my/our cattery/household, no cat owned by me/us or living at the same address will attend any Show / Exhibition until at least one month after all cats owned by me/us or living at the same address have been examined by a Veterinary Surgeon and pronounced free from any evidence of the disease in question.  
(iv) Cats showing positive reaction to the Feline Leukaemia Virus blood test or Feline Immunodeficiency Virus blood test must not be shown. Vaccination against Feline Leukaemia is also available.  
N.B. Council strongly recommends that all cats should be regularly tested.
- (d) I/We agree to abide by any decision regarding rejection made by the examining Veterinary Surgeon.
- (e) To the best of my/our knowledge, the cat/s entered for this Show has/have not been subjected to any surgery to correct any defect listed in the GCCF Standard of Points.

NOTE: Cats from the same household/cattery may, however be shown at different shows on the same day.

**NOTES**

- 1 All Cats exhibited at this show, unless entered only in Non-Pedigree Classes, must previous to the Show, be registered with the GCCF. The transfer of ownership of a Registered Cat must in any event be registered at least 3 weeks previous to the show.
- 2 Write distinctly and note that the columns below must be filled in in terms identical with the registration of the cat at the GCCF.
- 3 Before posting, please check through to make sure that there are no errors or deviations from the Registration Certificate.
- 4 If Assessment Class entries, please give full description and enclose Standard of Points approved by the GCCF.
- 5 If booking EXHIBITION PEN(S), please give FULL details for the catalogue.
- 6 If the age be not known, the word "UNKNOWN" must be written in the space available.
- 7 This form MUST be written and signed entirely in INK, under penalty of disqualification.
- 8 Only one line need be taken for each Cat, although the cat may be entered in several classes, provided that the classes in which it is entered are placed opposite the name in the column provided.
- 9 Each cat must be entered in a Minimum of 4 and a Maximum of 9 Classes, one of which must be an Open/Assessment Class.
- 10 Please enclose a stamped, addressed postcard if acknowledgement of entry is required.
- 11 Please note that in addition to the classes you have entered, your cat may also be handled for the purpose of assessing candidates in the GCCF Judge appointment scheme.
- 12 The banks are now charging up to £10.00 each time a cheque is returned 'refer to drawer, please re-present'. It is with regret that should your cheque be so returned we cannot accept your entry until the cheque is cleared and the subsequent charge repaid to the club.
- 13 Exhibitors must NOT enter a club class unless they are a fully paid up member of that club.
- 14 ALL EXHIBITS MUST BE ACCOMPANIED BY OWNER OR OWNER'S REPRESENTATIVE
